There are 3 compliance items that are required by either State or Federal law to be completed prior to volunteer participation within the lowa Soccer Association. Without completion volunteers can be stopped from participation. All of the compliance courses can be completed within the USSF Learning Center.

The Concussion Certificate is obtained by completing the Intro to Safe and Healthy Playing Environments Course Within the USSF Learning Center

Volunteers should complete these courses as quickly as possible following registration. After volunteers are rostered to a team, the Sports Connect system will check with the USSF Learning Center for course completions for 7 consecutive days. If results are found, they will automatically be uploaded to volunteers Sports Connect Profile.

If volunteers do not complete the courses within 7 days of being rostered to a team, they will need to click the 'Get Learning Center Updates' button which can be located within your My Account page in the Sports Connect Association platform. Club registrars as well as the ISA state office also have access to the 'Get learning Center Updates' button for all of their volunteers. <u>Access the USSF Learning center here: https://learning.ussoccer.com</u> then click the Safe Soccer tab Required Compliance:

1. SafeSport Certification (Can be obtained within the USSF Learning Center)

Concussion Certification (Within the USSF Learning Center by taking the Intro to Safe and Healthy Playing Environments Course)
 Completed and approved Background Check. This is automatically run once your register and may take up to 10 business days to return results.



You will see that my risk expiration date is shown. You will see that I am safesport verified. You will also see that my coaching license showed up in my profile. The coaching license will also show up on the coach passes in this system (maybe not immediately but within a few hours of setting up your profile)! My only non-compliance item is the concussion training. This will take place through the learning center and will be linkable from my profile page once that goes live in early June. Coaches can also choose to upload certificates and coaching licenses into this profile page and the state can verify those.

Coaches can use this web address to access their US Soccer Learning Center profile where they can find both their Safesport training AND their Concussion training - <u>U.S. Soccer Learning Center</u> (<u>ussoccer.com</u>). If you aren't immediately directed to the Safe Soccer tab in this website, access that. Your concussion training is labeled – Introduction to Safe and Healthy Playing Environments.
